Course Description:

This class provides 10 key special topics on international investment law, including (1) the fundamental theories concerning international investment law, (2) subjects of international investment law and the related development, (3) treaties on international investment and the interpretations, (4) foreign direct investment laws, overseas investment legal system of capital exporting countries, (5) treatment of investors and standards of host state behavior, (6) legal issues on expropriation and typical cases, (7) compensation and typical cases, (8) public interest issues and typical cases, (9) trade (including technology transfer)

and international investment law, (10) dispute resolution focusing on arbitration . We will not examine specific elements of the international investment legal system.,

Course Goals:

The goal of the class is to explore the major topics on international investment law and the related development with students, and help them grasp the tools of legal analysis to analyze the important issues and typical cases in the field of international investment.
